FOR EFFECTIVE MARSHALLAN LEADERSHIP

eadership traits and skills are attributes that naturally come to some people. However to others, these valuable traits can be cultivated. In the Noble Order of the Knights and Ladies of Marshall, quite a number of people who exhibit leadership traits progress through the Order holding various leadership positions and they effectively use these positions to further champion the progress of the Order.

The aim of these series of articles on leadership is to bring to the fore the fact that leadership is an active process that one who occupies a leadership position constantly undertakes.

WHO IS A LEADER: A leader is one who influences or motivates a group of people to act towards achieving a common goal. Leadership therefore is the art of engaging in this activity. Put even more simply, the leader is the inspiration and director of the action. He or she is the person in the group that possesses the combination of personality and leadership skills that makes others want to follow his or her direction.

ARE LEADERS BORN OR MADE?

While there are people who seem to be naturally endowed with more leadership abilities than others, people can learn to become leaders by improving their respective skills. History is full of people who, while having no previous leadership experience, have stepped to the fore in crisis situations and persuaded others to follow their suggested course of action. The best estimates offered by research are that leadership is about one-third born and two-thirds made.

DIFFERENT LEADERSHIP

TYPES: Many leadership scholars have proffered different types of leadership styles. For our purpose, I will only limit it to four leadership types. These are a utocratic, democratic, transformational and laissez-faire leadership types.

AUTOCRATIC LEADERSHIP:

Autocratic leadership style is centred on the boss. In this leadership the leader holds all authority and responsibility. These type of leaders make decisions on their own without consulting subordinates. They reach decisions, communicate them to subordinates and expect prompt implementation. Autocratic work environment does normally have little or no flexibility. In this kind of leadership, guidelines, procedures and policies are all natural additions of an autocratic leader.

DEMOCRATIC LEADERSHIP: In

this type of leadership style, subordinates are involved in making decisions. This headship is centred on subordinates' contributions. The democratic leader holds final responsibility, but he or she is known to delegate authority to other people, who determine work projects. The most unique feature of this leadership is that communication is active upward and downward. This leadership style is one of the most preferred leadership types and it entails fairness, competence, creativity, courage, intelligence and honesty.

TRANSFORMATIONAL

LEADERSHIP: The transformational leadership style depends on high levels of communication from management to meet goals. This style of leadership requires the involvement of management to meet goals. Leaders focus on the big picture within the organisation and delegate smaller tasks to the team to accomplish goals.

LAISSEZ-FAIRE LEADERSHIP:

Laissez-faire leadership gives the authority to subordinates who are allowed to work as they choose with minimal or no interference. From my research, this kind of leadership has been consistently found to be least satisfying.

PERSON, PURPOSE AND PEOPLE:

There are some basic elements in the leadership process that should occupy our attention.

These are *Person*, *People and Purpose* or the 3 Ps. A position of office is no guarantee of leadership but it helps in the sense that a leadership position usually commands a listening ear from its people and that is a good starting point for anyone who desires to be a leader.

A leader by its meaning is one who goes

first and leads by example, so that others are motivated to follow him. This is a basic requirement. To be a leader, a person must have a deep-rooted commitment to the goal that he will strive to achieve even if nobody follows him! Joshua was such a man. He was publicly appointed to succeed Moses (Num. 27:12-23). The goal was to lead the Hebrews cross over the Jordan and take the land (Josh 1:1-2) ... and that was what he did.

In his old age, there remained much land to be possessed.

PURPOSE: A requirement for leadership is personal vision - the ability to visualize your goal as an accomplished fact; a thing already achieved. "The very essence of leadership is that you have to have vision. You can't blow an uncertain trumpet." Theodore M. Hesburgh.

How do you become a leader with a purpose? You need guidance (*Prov 3:5-6*) and you will get it through meditation on the Word of God.

The next requirement is the realization that the goal cannot be achieved alone, without the help of others. In the latter, you face a greater challenge. But whatever the situation, the leader must integrate his or her (or the organization's) goal with his followers' personal goals and then communicates this goal in such a way that they embrace it too and the goal becomes a common goal.

"The leader has to be practical and a realist, yet must talk the language of the visionary and the idealist'- Eric Hoffer. In communicating your goal, bear in mind that it should meet the following criteria: Achievable: realistic yet faith stretching; Inspiring: challenging your people to give of their best; Measurable ... Quantifiable; Shared: declaring your conviction in and commitment to the goal

PEOPLE: To be a leader, one must have followers. To have followers, one must have their trust. Why are some individuals more effective than others at influencing people? Effectiveness in leadership has been attributed to persuasion skills, leadership styles and personal attributes of the leader.

In subsequent articles, we will look at personal attributes of effective leaders and mistakes leaders must avoid.







The Lectures were held to immortalise the memories and extoll the legacies of the first three Bishops of the Sekondi-Takoradi Diocese, Most Revs. Joseph Amihere Essuah, Charles Kweku Sam and John Martin Darko.

Bishop Essuah shepherded the Diocese from November 20, 1969 to October 7, 1980; Bishop Sam from September 30, 1981 to January 13, 1998 and Bishop Darko from June 27, 1998 to December 14, 2011.

UOTES FROM THE LECTURES

POSITION OF THE FAITHFUL

Catholic faithful in Ghana should not be

ashamed of their faith but profess that they know the one in whom they have put their trust then Ghana can be transformed in to a better country.

"The witness of life and word demands that we march our words with our life so that what we say corresponds to what we do.

Our world today does not want teachers but models; people who take the lead and invite others to follow them instead of sitting in their comfort zones and pointing out the way to others without they themselves ever taking that way."

MPOWERING THE LAITY

Priests should empower the Laity to take up their rightful place in the Christian Community or Parish since they constitute an important segment towards the effectiveness of the Priests.

" The Church desperately needs the Laity to carry out this role with the authority, creativity, and power that the Holy Spirit has given them in Baptism. Because of Baptism and Confirmation, all Catholics have the right and duty to preach the Gospel to all. They are to do this either individually or grouped in associations."

NOWING THE WORD OF GOD

In order to adequately and convincingly preach the Gospel, the Laity must know the Word of God. Knowledge of the Word of God is acquired through reading, studying, sharing and praying the Word of God.

distress in all sorts of ways, as sadness, anxiety, addictions, unproductive obsessions, unwanted compulsions, repetitive self-sabotaging behaviours, physical ailments, boredom, and as all sorts of angry, bleak, and agitated moods. This state of affair can be resolved through medicines and psychotherapy. Setting those two aside, what else helps?

TEN TIPS FOR EMOTIONAL HEALING

Be yourself: You must be yourself. This means asking for what you want, setting boundaries, having your own beliefs and opinions, standing up for your values, wearing the clothes you want to wear, eating the food you want to eat, saying the things you want to say, and in a hundred other ways being you and not somebody small or false.

Invent yourself: You come with attributes, capacities and proclivities and you are moulded in a certain environment. You reduce your emotional distress by deciding to become a person who will experience less emotional distress: a calmer person, a less critical person, a less egoistic person, a more productive person, a less self-abusive person, and so on.

Love and be loved: Part of our nature requires solitude, alone time, and a substantial rugged individualism. But this isn't the whole story of our nature. We feel happier, warmer and better, live longer, and experience life as more meaningful if we love and let ourselves be loved. We acknowledge the reality of others, include others in our plans, not only speak but listen, and make ourselves fit by eliminating our more egregious faults and by growing up.

Get a grip on your mind: Nothing causes more emotional distress than the thoughts we think. We must do a better job than we usually do of identifying the thoughts that don't serve us, disputing them and demanding that they go away, and substituting more useful thoughts. Thinking thoughts that do not serve you is the equivalent of serving yourself up emotional distress. Only you can get a grip on your own mind; if you won't do

that work, you will live in distress. Forget the past: We are not so completely in control of our being that we can prevent past sore points from returning. They have a way of pestering us as anxious sweats, nightmares, sudden sadness, and waves of anger or defeat. But we can nevertheless try to exorcise the past by not playing along with our human tendency to wallow there. We must tell ourselves to move on and mean it. If you have a secret attachment to misery, you will feel miserable. As best you can, imperfectly but with real energy, let go of the past and forget the past.

Flip the anxiety switch off: Rampant anxiety ruins our equilibrium, colours our mood, and makes all the already hard tasks of living that much harder. There are many anxiety management strategies you might want to try-breathing techniques, cognitive techniques, relaxation techniques. What will make all the difference is if you can locate that "inner switch" that controls your anxious nature and, deciding that you prefer to live more calmly, flip it to the off position. With one gesture you announce that you will no longer overdramatize, that you will no longer live a fearful life or create unnecessary anxiety for yourself.

Make Meaning: Meaning is nothing more arcane than a certain sort of subjective psychological experience. We can have much more meaning in our life if we stop looking for it, as if it were lost or as if someone else knew more about it than we did, and realize that it is in our power to influence meaning and even make it. By making daily meaning investments and by seizing daily meaning opportunities, we hold meaning crises at bay and experience meaningful life; meaning life which reduces stress.

Let meaning trump mood: You can decide that the meaning you make is more important to you than the mood you find yourself in. Rather than saying *I am*

blue today you instead say, I have my business to build or I have my novel to write. You start each day by announcing to yourself exactly how you intend to make meaning on that day, how you intend to deal with routine chores and tasks, how you intend to relax-how, in short, you mean to spend your day-and you consider all of that, the rich and the mundane alike, as the project of your life, one that you are living with grace and in good spirits.

Upgrade your personality: You may not be the person you would like to be. You may be angrier than you would like to be, more impulsive, more scattered, more self-sabotaging, more undisciplined, more frightened. If so, you require a personality upgrade, which of course only you can supply. You choose a feature of your personality you would like to upgrade and then you ask yourself, what thoughts align with this intention and what actions align with this intention?

Deal with circumstances: Would you experience more distress sunning yourself at the beach or facing a long jail sentence? Circumstances matter. Our economic circumstances matter; our relationships matter; our work conditions matter; our health matters; whether our nation is at peace or occupied by invaders matters. Many circumstances are completely out of our control and many are within our control. We can change jobs or careers, we can divorce, we can reduce our calorie intake, we can stand up or keep quiet, we can do exactly as much as we can do to improve our circumstances.

Emotional healing requires that you take real action in the real world. Who knows if we are in the throes of a new depression epidemic or a new anxiety epidemic or whether keen emotional distress has been a significant feature of human existence from the beginning. What is different now is that the paradigm of self-help is completely available to anyone who would like to reduce his or her emotional distress. You can understand yourself; you can form intentions and carry them out; you can learn from experience; you can grow and heal. Naturally none of this is true if you are unwilling to do the work required. But if you are, you have an excellent chance of reducing your emotional distress and experiencing genuine emotional health.

NOBLE ORDER SPEAKS ON HOMOSEXUALISM AND THE ENVIRONMENT

7E, members of the Standing Committee of the Supreme Council of the Knights of Marshall, at a meeting held in Sekondi from January 12-14, 2018; AND HAVING discussed the presentations by Most Rev Joseph Osei-Bonsu, Bishop of Konongo-Mampong and our Supreme Spiritual Director, on the theme: "KNIGHTS AND FAMILY LIFE AS A NUCLEUS OF THE CHURCH AND SOCIETY;" AND Sir Kt Bro. Dr. Peter Acquah, Chairman of the Historical, Research and Beatification Committee of the Knights of Marshall on: "MAN'S RESPONSIBILITY TOWARDS GOD'S CREATION AND OUR COMMON HERITAGE, THE ENVIRONMENT;" **AND** having taken into consideration the tenets of the Noble Order founded on Unity, Charity and Fraternity and our faith in The Holy Mother, the Catholic Church; **IMBUED** with patriotism, nationalism and altruism:

DETERMINED to continue to work towards the upliftment of the poor and the needy through charity works; Recognizing that our Common Home, The Earth is at risk through human activity;


