s at May 27 2020, 7,117 COVID-19 cases have been reported in Ghana. So far the Government has introduced some bold policies and directives aimed at stemming the continued spread of the Pandemic. It has introduced partial lockdown in the epi-centres of Accra, Kumasi, Tema and Kasoa and Social Restrictions nationally. These measures are to help stop the spread of the Pandemic and save lives through social distancing.

Ghanaians are socially and culturally very active. These restrictions could therefore have major psychological and physical effects on the populace if appropriate adaptive and active measures are not taken. There could be challenges of loneliness, anxiety and depression. Boredom can be more devastating for some people than COVID-19. Reduction in physical activity as a result of restrictions in movement could also result in weight gain, joint problems and *thromboembolic* (blood clot) conditions in predisposed individuals. Some may even over-indulge in food and alcohol in response to depression tendencies.

To stay connected with friends, family and workmates, social media comes in handy. We should however ensure that information that are posted or forwarded are correct and are from reliable sources. In extreme cases, especially for persons who are infected or affected by Covid-19 and have to self-isolate or go under quarantine, psychological support may be needed as

these can be very stressful. They should not shy away from seeking help from Counsellors, Clinical psychologists or Psychiatrists.

To reduce boredom and stay active, movies, music, indoor games such as scrabble, ludo, monopoly, oware can be enjoyed with the family. It will be good to use the time for family togetherness and bonding. This is a good opportunity to read more books.

A nutritious balanced diet consisting of adequate amounts of carbohydrates, proteins, vegetables and fruits is essential for keeping good health under such restrictive circumstances. No supplementary feeding (vitamins and minerals) is needed except for individuals with special needs. Negative practices such as excess intake of food and alcohol should be avoided.

Where feasible, walks can be carried out on the compound or on staircases. Indoor exercises, such as aerobics, skipping and press-ups are helpful for keeping fit.

*Finally*, it will be good to use the opportunity to read and meditate on the word of God and spend time in prayer to enhance our spiritual development.

and so the human brain play a great role whether we are a contact, quarantined or isolated. When our certainty is questioned for example, our stress response goes haywire, instantly arousing our fight-orflight reaction, prompting you to take action in order to get you to safety.

Waiting for certainty as in laboratory confirmation or otherwise of COVID-19 as a contact, in quarantine or isolation in relationship to COVID-19 can feel like torture by a million tiny cuts as our brain prefers to know an outcome one way or another to take the urge off.

The fight against the COVID-19 pandemic would be won side by side with our health care providers, government, religious bodies, traditional rulers and citizens of Ghana.

For everyone involved in this COVID-19 pandemic fight, we need to take note of the following to help our colleagues or employees who have been exposed, quarantined and isolated.

- Adjust appropriately to their personal care, functioning in the family, work and society.
- Help minimise stigma situation and its psychological related challenges
- And prepare to admit or discharge a person as contact, quarantined or isolated in relation to COVID-19.
- There is need for the involvement of professionals like psychologists and counsellors to prepare them for their reintegration back into society.

In this regard, the support of families and co-workers will be crucial so as to deal with any concerns, perceptions or fears as a way of improving their health and enhancing their reintegration process and productivity.

Psychosocial interventions are services designed to provide counselling, assistance to accessing other services, access to skilled and professional help, assistance with the development of strategies to reduce harm, and access to specialist advice and information. These services can be provided to individuals or to groups. Psychological intervention could also be in

i sychological intervention could also be in

a form of helping a person to cope with the stressors of a life event. These could be a health challenge such as COVID-19, work related, home based, relationship issues and developmental issues. Psychosocial interventions takes many forms and fall under two main umbrellas of therapy, namely cognitive and behavioural therapy. Psychological interventions attempts to establish certainty in an uncertain situation







# Noble Order Makes Donation



# **Enforcement of Contracts:**

The Element of Capacity.

ontracts are regular features in almost every aspect of life. Whenever one finds himself reaching an agreement after going through a negotiation some form of contract

is created in one way or the other. Contractual relationships are created through sale of goods and services, tenancy, insurance, employment, acquisition of land among others.

In all these, there are certain vital elements that run through them, namely, agreement (offer and acceptance) by the parties; The parties must have capacity; consideration (price element) which is not only limited to money, and the creation of legal relationship enforceable by the courts.

Capacity is the ability of a person or party to enter into a valid contract. A valid contract can be **voidable**. A voidable contract, however, is binding on the parties unless it is **avoided** or **declared void** by a party who is legitimately exercising a right to avoid contractual obligations. For contractual purposes, a person could be natural (human being) or artificial i.e. companies, government, educational institutions. Basically, a party may either have full capacity or lack capacity.

A person is considered to lack or have limited capacity when he or she is vulnerable and requires to be protected from unscrupulous persons who may want to take advantage of their situation. These persons include infants (minors), drunkards and lunatics.

Under the laws of Ghana, a person reaches the age of majority at 18.

At this age, the person can enter into a contract and is qualified to vote and can make a will. (see Article 42 of the Constitution, 1992; Section 1 of the Children's Act, 1998 (Act 560). Any person below the age of 18 is therefore

considered as **an infant**. In principle, contracts by or with a minor or an infant are unenforceable. However, certain types of contracts entered into by or with an infant are enforceable. Consequently, an infant can sue or be sued in respect of such contracts.

An infant can enter into a contract for necessities such as food, clothing, and shelter. Necessaries are defined under section 2(3) of the Sale of Goods Act, 1963 (Act 137) as goods suitable to the condition in the life of the person to whom they are delivered and to his actual requirements at the time of the delivery. What is necessary can only be determined after considering the circumstances of a particular case. An infant can also enter into contracts that are beneficial to him or her. The beneficial nature of such contracts are determined by the time they were made. i.e.; learning a trade (apprenticeship) and other services aimed at enhancing education and skill acquisition. Additionally, an infant can enter into contracts of employment. However, such contracts are unenforceable if the demands of the employment far outweighs the benefits the infant stands to gain. (The Children's Act, 1998 (Act 560) permits only light work and prohibits any work that endangers the life and development of a child.

Apart from these, there are some other contracts that are binding on an infant unless those contracts were avoided while the person was still an infant or avoided them within a reasonable time after reaching majority age(adulthood).ie. are share transactions and leases of real property.

#### **UNSOUNDNESS OF MIND**

The issue relating to the unsoundness of mind could be used as a defence against the enforcement of a contract. A person of unsound mind may not be positioned to appreciate the consequences of his or her actions. However, it must be proved that the party making a claim of insanity was of unsound mind in fact and that the other party to the contract knew about that fact. The reasoning behind this position of the law is that insane persons may have lucid moments. Unsoundness of mind therefore does not automatically make a contract void. It rather makes a contract voidable.

Similarly, a contract can also be avoided (by a drunk party) if the other party knew that the person he was entering into contract with at the material time was drunk to the extent that he or she was not in a position to appreciate the consequences of his action. However, when the drunk regains sobriety and ratifies party (approves) the contract it becomes binding. Whether the contract is ratified or not it would still be valid until a court grants the drunk party the right to avoid the contract. The success of this relief by the courts may not be guaranteed in all circumstances.

In Ghana, the government enters into contract through its ministries, departments and agencies(MDAs). These MDAs enter into contracts in their own name. However, when the need arises to enforce such contracts by or against a ministry, the Attorney-General has the sole capacity to sue or be sued as provided under section 9 of the State Proceedings Act, 1998 (Act 555).

Corporate bodies such as companies and partnerships are considered as **artificial legal persons**. As artificial legal persons registered under the appropriate laws, they have the right to enter into contracts in pursuance of their business. Consequently, they also have the right to sue and be sued to enforce contracts.

Lastly, it is important to note that it is against public policy to enforce contracts which have an enemy alien as a party. An enemy alien under international law is a person (a citizen or national) from a foreign country which is at war with a domestic nation. Enforcing such contracts would mean providing assistance to the enemy or supporting the cause of such country.



We recall with pride, that it was under his able leadership that the Bridge moved to a 32-page full colour Magazine with the tacit approval of the Supreme Council. It was during his tenure of office that the financial fortunes of the Bridge Magazine improved dramatically from its negative balance sheet and started to show positive gains which resulted in the payment of dividends to the Grand Court and Supreme Council for some development projects."

#### EDUCATION AND CAREER

Sir Kt Bro Cdr. Prempeh a trained teacher, versatile journalist, a staunch Catholic and a foot soldier of Christ was an inspiration to all those he encountered. He had to his credit several awards including those giving by the Ghana Broadcasting Corporation the Catholic Archdiocese of Accra, Martyrs of Uganda Parish, Patrons of the Choir, and Past Students of St. Augustine's College (APSU).

His work was not limited to the choir alone. During his retirement, the Church was the number one place he loved to go. His unwavering dedication and pieces of advice given to the Holy Family Akan Society at the Martyrs of Uganda Parish for its spiritual and physical growth were immeasurable. He was a proud **Ekuo Agya**, (father of the association) who supported his people in diverse ways.

He also played multiple roles in Church – related programmes and stopped at nothing to render selfless services to the Holy Roman Catholic Church.

Notable among these were his membership and outstanding performance in the committee which planned the visit of Pope John Paul II to Ghana in May, 1980. He was also a member of the music Sub-Committee of the Centenary Planning Team of the Catholic Church in Accra. Sir Kt. Bro. Cdr. Prempeh also served as a member of the Pan-African Malagasy Laity Seminar in Accra which saw African Catholic leaders coming together to discuss the role of the Church in Africa.

## KNIGHTS OF COLUMBUS UNVEILS NEW INITIATION CEREMONY THAT WILL BE PUBLIC

**NASHVILLE, TENN.** — After 142 years, the Knights of Columbus is pulling down a veil of secrecy that has surrounded its initiation ceremonies in an effort to better showcase the order's core principles and its drive to help Catholic men become disciples.

Since its founding in 1882, the initiation ceremonies for the first three degrees of Knights membership — focused on the principles of *unity, charity, and fraternity* — have been separate and open to members only. The fourth degree, dedicated to the principal of patriotism, was added later and this initiation also is secret and for members only.

But starting this year, the Knights have adopted a new ceremony. Called the *Exemplification of Charity, Unity and Fraternity,* it combines the initiation for the first three degrees into a single ceremony that will be open to family, friends and fellow parishioners.

"There is nothing we do that is secret or needs to be secret," Supreme Knight Carl Anderson told the Tennessee Register, newspaper of the Diocese of Nashville. "We decided this is a way to let other parishioners know, family members know, what the Knights of Columbus is all about. We think that's a good thing."

The Knights of Columbus is a fraternal organization of Catholic men that was founded by Fr. Michael McGivney, a young priest serving at St. Mary Church in New



Haven, Connecticut. McGivney is a candidate for sainthood and has the title *"Venerable."* 

Today, the Order has more than two million members worldwide who are involved in charitable and service works.
